The candidates will be informed individually by the office of the Principal Chief Personnel Officer, N. F. Railway, Maligaon, Guwahati. All candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.

This is a Provisional **Part Panel** prepared after keeping vacancies for the candidates for which medical fitness report is awaited and for replacement of candidates absent during the document verification.
