On the basis of the performance in 1st Stage Computer Based Test (CBT) held from 09.08.2018 to 31.08.2018 and on 04.09.2018, 2nd Stage CBT held from 21.01.2019 to 23.01.2019 and on 08.02.2019, the verification of the documents of candidates held from 17.06.2019 to 25.06.2019, 05.08.2019 to 08.08.2019 and absentee Document verification held on 11.08.2019 against CEN No. 01/2018, the waitlisted/standby candidates with the following Roll Numbers have been provisionally empanelled against the post of Technician Gr.III/C & W (Cat. No. 25), Technician Gr.III/Dsl. Mech. (Cat. No. 34), Technician Gr. III/Fitter/Electrical (Cat No. 59), Technician Gr. III/Fitter/Engg. (Cat. No. 61) Technician Gr. III/Signal (Cat. No. 134) and Technician Gr. III/Tele (Cat. No. 136) under CEN-01/2018 and their names are being forwarded to Principal Chief Personnel Officer, Northeast Frontier Railway, Maligaon for filling up of the vacancies. Further course of action on their appointment will be taken by Principal Chief Personnel Officer, Northeast Frontier Railway, Maligaon, Guwahati after due verification & ensuring fulfilment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Oualification, Date of Birth. Caste, Character/antecedents/Affidavits where necessary and Medical Examination etc. according to the Centralised Employment Notice No. 01/2018 and corrigendum issued thereto from time to time. The candidates should await for further correspondence from Northeast Frontier Railway in this regards.

The candidates will have to give an undertaking to Northeast Frontier Railway for undergoing Medical Examination again for ascertaining their medical fitness (suitability) for the post. In case they are not found fit, their candidature will not be considered. The medical examination will be conducted by the Northeast Frontier Railway as per extant procedure.
