Notice for 4th Round of Document Verification and Medical Examination for the Technician- Grade-III Posts of Pay Level-2

- **1.** The 4th round of Document Verification (DV) for the post of Technician-Gr. III (Level-2) for the candidate shortlisted for RRB/Siliguri is scheduled to be held on 04.08.2025 at the office of Railway Recruitment Board, Siliguri premises.
- 2. SMS/E-mail alerts are being sent to the candidate's registered mobile/email ID for downloading his/her e-call letter from the official website of RRB, Siliguri. Candidate is advised to regularly visit RRB's official website for the updates.
- **3.** Candidate can download the DV e-call letter from the official website of RRB/Siliguri (www.rrbsiliguri.gov.in) 10 days prior to scheduled date of DV for the candidates.
- 4. Candidate has to upload his/her signature, latest photograph and identification marks in the portal https://oirms-ir.gov.in/rrbdv/. The instructions for uploading them are available on this portal. This portal will be become active 10 days prior the date of DV. Candidate is advised to read the detailed instructions given in the DV e-call letter carefully.
- **5.** As detailed in the CEN and e-call letter issued for Document Verification, the candidate called for DV should produce all the original documents along with two sets of self-attested photo-copies in A4 size and also bring three (3) Passport size latest colour photographs at the time of DV.
- 6. The candidate who is called for the 4th round of Document Verification may note that after completion of DV, he/she will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of RRB, Siliguri on the next day of the DV. A ccordingly, the candidate is required to come prepared to stay for three to four days. Candidate has to pay the prescribed medical fee of Rs. 24/- only.
- 7. The candidature of the shortlisted candidate is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency / deficiency / discrepancy detected in the information furnished by him/her in his/her online application or any malpractice on his/her part coming to the notice at any stage of the recruitment process or thereafter.
- 8. It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.
- **9.** The detailed instructions and guidelines will be issued in DV e-call letter. Candidates are advised to read the detailed instructions given in the DV e- Call letter carefully and submit all the required certificates/ documents at the time of DV.
- **10.** While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical / printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.
- **11.** Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerized and the selection is based on merit of candidates only.
