**Viewing of Question Paper, Responses and Keys & Raising of  
Objections if any to Questions/Options/Keys**

The Computer Based Test for Pay Level 1 against CEN RRC 01/2019 was conducted from 17.08.2022 to 11.10.2022 in various phases. In order to enable candidates who appeared in the CBT to view their question papers, responses and answer keys, a link will be provided on the websites of RRBs which will be active from 14.10.2022 @ 13:00 Hrs to 19.10.2022 @ 23:55 Hrs.

After viewing the details as above, objections if any regarding the questions, options and keys can be raised by the candidates for which the time schedule, fee and procedure is given below:

**1. TIME SCHEDULE :**

SN	Activity	Date and Time
1.	Viewing of Question Paper, Responses and Keys.	14.10.2022, 13:00 hrs onwards
2.	Viewing and Raising of objections against the Questions, Options and Keys and online fee payment.	15.10.2022, 10:00 hrs onwards
3.	Closing of the Viewing of Question Paper, Objections raising and payment window.	19.10.2022, at 23: 55 hrs

**2. FEE:**

The prescribed fee for raising objection is **Rs.50/- plus applicable Bank Service Charges per question.** In case the objection raised is found to be correct, the Fee Paid against such valid objections shall be refunded to the candidate after deduction of applicable Bank charges. The refund will be made to the account from where the candidate has made the online payment.

**3. MODE OF PAYMENT OF FEE :**

1. All Bank Debit Cards/Credit Cards are allowed.
2. Rupay Cards/ UPI are allowed.
3. Multi Bank Retail Net Banking /Multi Bank Corporate Net Banking are allowed.
4. Axis Retail Net Banking / Axis Corporate Net Banking are allowed.

**4. PROCEDURE FOR RAISING OBJECTIONS:**

The detailed procedure with necessary guidelines will be available in the link provided on the official website of RRBs.

5. Candidates are advised to raise objection(s), if any, well before the final date and time i.e. 19.10.2022 at 23:55 Hrs, after which no representation from the candidates on the questions, options, keys etc. will be entertained.
6. The decision of RRBs on the objections raised shall be final and binding and no further correspondence shall be entertained from the candidates in the matter.
