All candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.

This is a Provisional **Part Panel** prepared after keeping vacancies for the candidates for which medical fitness is awaited and for replacement of candidates absent during the document verification.
