Further course of action on their appointment will be taken by Principal Chief Personnel Officer, N. F. Railway, Maliagon Guwahati after due verification & ensuring fulfilment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Qualification, Date of Birth, Caste, Past Character/antecedents/ Affidavits where necessary and Medical Examination etc. according to the Centralised Employment Notice No. 03/2018 and corrigendum issued thereto from time to time. Candidates will be informed individually by the office of the Principal Chief Personnel Officer, N. F. Railway, Maligaon, Guwahati. The candidates should await for further correspondence from N. F. Railway in this regards.

The candidates will have to give an undertaking to N. F. Railway for undergoing Medical Examination again for ascertaining their medical fitness (suitability) for the post. In case they are not found fit, their candidature will not be considered. The medical examination will be conducted by the N. F. Railway as per extant procedure.
