List of Candidates shortlisted for Document Verification (Pay Level-2)

1.0: Candidates bearing the Roll Numbers listed herein under have been provisionally shortlisted for the Document Verification (DV) for the posts notified in Pay Level – 2, based on their score in 2nd stage CBT and the priority for the posts in Category- 11 and 13 furnished by them (in Level-2) in the online application. This list of shortlisted candidates for DV is drawn based on the balance candidates in Cat- 11 & 13 (on account of replacements against absent candidates during Document verification & Candidates earlier called for document verification in category - 11 & 13 for which Medical fitness is awaited) and for future changes in allotment of candidates among Cat-11 and Cat-13 on account of the inadequate medical fitness for the respective Category etc. This list of shortlisted candidates for DV is drawn based on the revised vacancies published in the websites of RRBs, subject to availability of eligible candidates. Since there will be lot of changes in cut off marks among various Categories/ Communities on account of various factors like absentism, Medical fitness, ineligibility found during Document Verification etc. the cut off marks for level-2 will be published after finalisation of selection against level-2.

2.0: The date for Document Verification (DV) will be announced in due course on the website of RRB, Siliguri. The candidates scheduled for DV will get an email and SMS to download their e-call letter from RRB Website. Candidates are advised to regularly visit RRB's official website for the updates.

3.0: Candidates may note that after successful completion of DV, they have to undergo Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRB. The candidates are required to come prepared to stay for three to four days. Candidates have to pay the prescribed medical fee of Rs.24/-. Accordingly, candidates have to come prepared for DV and medical examination.

4.0: The shortlisted candidates for DV should produce all the original documents along with two sets of Xerox copies in A4 size as detailed in the CEN and e-call letter.

5.0: Candidature of all the shortlisted candidates for Document Verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.

6.0: While every care has been taken in preparing the list of candidates shortlisted for Document Verification, RRB reserves the right to rectify any inadvertent error or typographical/printing mistakes. RRB regrets for the inability to entertain any correspondence from unsuccessful candidates.

7.0: Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is based purely on the merit of the candidates.

8.0: The Roll Numbers of provisionally shortlisted candidates for Document Verification are arranged horizontally in ascending order and not in the order of merit.
